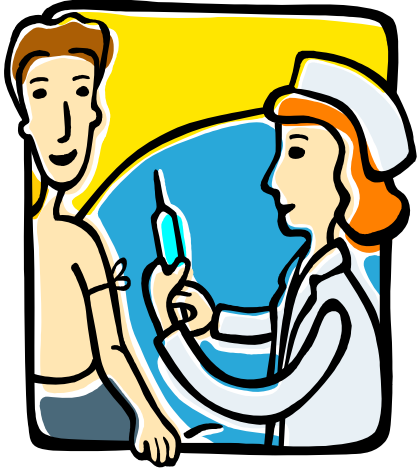

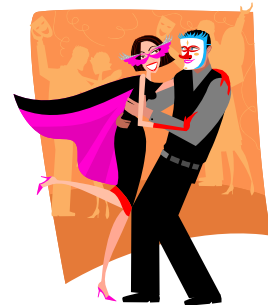

Workers' Comp Group Rating Enrollment Forms Mailed ***Qualifying Businesses Should Respond Quickly***

Savings quotes and enrollment packets for **Compensation Consultants Inc (CCI)** and the **Buckeye Workers' Compensation Alliance** Workers' Compensation Group Rating Program will soon be sent to newly qualifying applicants.

Because group rating has a limited window for enrollment, it is important to apply immediately for the 2009-2010 plan year. The deadline to request a quote is January 25, 2009, so complete and return your application to CCI as soon as possible.
